Forms:

I understand my camper's registration may require additional forms to be completed, and submitted no later than my camper's first day of camp. I understand if I do not have the completed forms, my camper may not be admitted to camp until all forms are completed. Forms may include medication authorization form, allergy medical alert form, immunization records and custodial agreements.

Daily Activity, Swimming, Field Trips:

I give my child/ children permission to fully participate in camp's activities, including swimming, and off site weekly field trips where transportation is provided through a Maryland licensed bussing company.

I understand and acknowledge the nature and extent of the activities that will be involved in the camp and assume the risk inherent in such activities on behalf of myself/ourselves and on behalf of our children. I voluntarily waive any and all claims, costs, liabilities, expenses (including attorney's fees), and judgments against Adventures in Camp, LLC ("AIC"), its directors, officers, employees, servants, subcontractors and agents and hereby release, excuse and discharge AIC, its directors, officers, employees, servants, subcontractors and agents from all claims, expenses (including attorney's fees), and judgments which may arise out of my child's/children's participation in camp and all aspects attendant thereto. The undersigned further agree(s) to indemnify and hold AIC, its directors, officers, employees, servants, subcontractors and agents harmless from any and all claims, liabilities, expenses (including attorneys fees) and judgments which may arise out of my child's/children's participation in camp and its activities.

If your child is held by any government, state, local or store official or security guard for theft, or any alleged illegal activity of any kind, we will leave your child in their care at their facility. It will be your responsibility to pick up your child from any location where they are accused of the said illegal activity. We will not hold up the rest of the campers at AIC, while waiting on your pick up from the said location. If your child is accused of any illegal activity, they will not be allowed to return to camp, and there will be no refund. AIC wants the best for our children and we display positive behavior and actions and we hope the campers will as well.

Medication Information:

My child has been seen by a physician within the past year, and is in good health to participate in physical activity at camp.

I will provide written permission for center staff to administer medication with written instructions from me, or the child's

health care provider, as permitted by local state licensing regulations.

I will complete and sign the authorization forms.

I will provide the medication in its original container (with the pharmacist's label for prescriptions).

Illness:

If center staff notifies me that my child is ill, I will pick up my child as soon as possible and no later than one (1) hour after being contacted.

If my child contracts a contagious illness, I understand that my child may return only when he or she is well, as described in the Adventures in Camp Welcome Guide.

NOT a Nut Free Facility:

Adventures in Camp, LLC ("AIC") is a facility that caters in food from local restaurants, provides snacks, and parents have the option of bringing in any meal and snack for their children. Therefore, AIC <u>CANNOT</u> guarantee a <u>NUT FREE</u> facility. I understand that AIC is <u>NOT A NUT FREE</u> facility. I further agree to release and hold AICE harmless from any liability for any allergic reactions or complications experienced by my child.

Emergencies:

In case of an emergency, I understand that center staff will attempt to contact me **immediately**. I also authorize center staff to:

-Administer first aid and/or cardiopulmonary resuscitation.

- -Transport my child via ambulance or other emergency medical service to a local hospital or other urgent care facility.
- -Obtain any emergency medical, surgical or dental treatment deemed necessary by medical authorities.
- -Transport my child to a local emergency shelter in the event of an emergency evacuation of the center.

Financial Obligations:

As the parent/ guardian signing this Enrollment Agreement all amounts due are ultimately my responsibility. Overdue accounts may be referred to a collection agency. I am responsible for all account balances, plus reasonable collection and attorney fees associated with the collection of the account. For bounced checks, the fee of \$25 will be applied.

Late Pick Up Fee:

I understand I may be charged a late pick-up fee if my camper is not picked up by the designated end time. I understand this fee must be paid no later than sign-in the next morning. I understand my camper will not be admitted to camp without payment. I understand repeated lateness can be cause for dismissal from camp.

Late Fees per child: 1 minute – 10 minutes = \$10.00 31 minutes – 60 minutes = \$60.00

11 minutes – 30 minutes = \$30.00 More than 60 minutes = \$120.00

Credits and Refunds:

Adventures in Camp, LLC ("AIC") canceled session – A credit and/or refund will be issued in situations where AIC cancels a camp session.

Weather related closings – no credits or refunds issued should weather cause closings including closing of pools and other water activities during thunderstorms, or other severe weather.

Absentee and Sick Camper – please see ill/sick camper policy in the parent manual. There is no reduction of fees if a child is absent from camp, including illness.

Damaged Property – Replacement costs of damaged or broken Adventures in Camp, LLC property, either accidentally or deliberately, is responsibility of the parent/guardian; this includes any property associated with camp operations, locations or vehicles.

Behavioral Issues and Suspensions – We give respect, we deserve respect. If a camper is suspended from camp, there will be no refund of camp fees. Camper may be dismissed from the program without notice if his/her behavior is consistently disruptive or if his/her behavior threatens the health and safety of himself/herself or the safety of other campers or staff. Behavior guidelines apply to a camper's parents, guardians or caregiver and a camper may be dismissed from camp for their actions.
